#### **RATIONALE**

Jesus Christ calls each one of us to fullness of life: "I have come that they may have life and have it to the full". (John 10).

Each person is precious in the eyes of God, worthy of the fullness of life, invited to a deep and personal relationship with Christ, called to membership of the Church community and to the help that can foster and support this relationship and membership. The chaplaincy is committed to helping each member of the school community to grow in faith and service, seeking to foster community cohesion and prepare students for life within a multi faith society.

### **AIMS and OBJECTIVES**

- 1. To foster in each individual a growing awareness of God's unique and infinite love for them and encourage a lasting and maturing relationship with him.
  - a. To offer daily opportunities for prayer and reflection.
  - b. To provide prayerful, meaningful liturgies especially Mass and the Sacrament of Reconciliation.
  - c. To offer an opportunity for pupils to experience the benefits of 'Retreat', where they can take time to pray, reflect and share with others.
  - d. To offer all pupils and staff opportunities to be involved in the work of the Chaplaincy.
  - e. To encourage pupils and staff to participate actively in the liturgical seasons of the year.
  - f. To establish clear whole-school procedures that will help to generate a supportive atmosphere for liturgies and assemblies.
  - g. To Prepare liturgies for staff on Training Days.
  - h. To actively involve priests from the Deanery within the life of the school.
  - i. To invite inspirational speakers who will give witness to their faith.
- 2. To encourage the whole school community to reflect God's love for us in the way we demonstrate our love for our neighbour
  - a. To co-ordinate charitable fundraising in the school encouraging staff and students to be involved
  - b. To offer spiritual guidance and counselling to individuals that require help.
  - c. To work with the referral panel team to identify some students who might benefit from chaplaincy intervention.
  - d. To encourage students to work with the vulnerable and marginalised e.g. party for students with severe learning difficulties
- 3. To give students the opportunity to hear and reflect on the teachings of the Catholic Church while appreciating the moral truths found among other Christian denominations and other faiths.
  - a. To nurture Christian Vocation in students and staff
  - b. To encourage staff and pupils to be actively involved in their parishes e.g. receiving the Sacrament of Confirmation, attending retreats etc
  - c. To foster links with the schools of the local Catholic Schools' Partnership and the Diocese of Northampton
  - d. To seek opportunities to work with students of other faiths both in our own school and elsewhere.
